The total number of sections taken together for classes XI and XII should not be more than 1/3 of optimum number of section allowed on the basis of land holding for any school.

The number of sections and students shall be restricted as per the actual facilities in the school.

Important Notes: The total number of section of the school shall be restricted to 38 as per appendix — V for the land area as per clause 3.4.1 of the affiliation bye-laws.

The school shall follow the SoPs of the Board in respect of all the labs.

As per RC report, the seating arrangement of library was temporary, Hence the school is directed to make proper seating arrangement in the Library. The school shall follow the SoP issued by the Board for library.

The school should have well developed sports facilities and shall follow the SoPs of the Board issued in this respect.

The school must ensure provision for CWSN such as ramp at the entrance, ramp / lift to access upper floor and separate toilets for girls and boys on every floor with proper infrastructural facilities in accordance with the provisions laid down in RPWD Act and submit compliance within 3 months on SARAS. For CWSN, boys washroom does not have urinals and at the entry stair could be seen which does not seems to be CWSN friendly. In the washroom of boys there was no separator between urinals. Moreover many of the washroom found locked during virtual inspection

The school shall conduct training of its teachers with CoE Pune within 3 months and submit the compliance.

The school is directed not to remove the mandatory disclosure section from its website and the videography link of the inspection /infrastructure from

The school shall get all the mandatory certificates renewed periodically.
