Claim : Application under Section 22 of the Maharashtra Public Trust Act, 1950.

ORDER BELOW EXH.01

(Passed on 12th day of February 2024)

By this application, the reporting trustee (the applicant) has seeking relief to accept the change report vide *section 22 of the Maharashtra Public Trust Act, 1950 (MPT Act)*.

02. Perused record. Heard. The application is filed in respect of change occurred in the Trust **due to change in registered office address of the trust.**

03. Having considered the above discussion and documents on record following points arise for my determination. Its findings along with reasons are recorded as under:

1.	Whether the change has been occurred in the trust? Yes
2.	Whether the change report is valid and Legal? Yes
3.	What order? As per final order

REASONS

04. It is now time to examine some of the applicant's broad and general arguments. According to the applicant, the change is occurred in

the trust as per rules and law. Hence, change report is required to be accepted in the interest of trust. In support of the submission the applicant has produced following documents on record:

Exh.02	Delay condonation application
Exh.03	NOC of trustees
Exh. 04	Electricity bill
Exh. 05	Evidence affidavit
Exh. 06	Notice of the meeting
Exh. 07	Minutes of the meeting



05. It is pertinent to consider the **Section 22(1) of the MPT Act**. It says as under:

“(1) Where any change occurs in any of the entries recorded in the register kept under section 17, the trustee shall, within 90 days from the date of the occurrence of such change, or where any change is desired in such entries in the interest of the administration of such public trust”

Emphasis in original

06. According to the aforesaid requirement, the applicant must file the application within 90 days of the change in the trust. However, the current application was filed after the limitation period has expired. However, Proviso of Section 22(1) provides that if there are satisfactory reasons for the delay, it may be considered. As a result, the grounds stated on the delay application are deemed satisfactory. As a result, application was allowed.

07. **Section 22(2)** of the MPT Act furthermore states, **“the inquiry can be held by the deputy or assistant charity commissioner in order to verify the entries vide section 17.”**

08. According to the provision above and after reviewing the documents on record, it was observed that the change occurred in the trust. The documents also indicated that the change reported by the

Reporting Trustee occurred in accordance with the law and in the way specified by the Trust. *Furthermore, the applicant's testimony has gone unchallenged. Nobody has raised an objection. As a result, application appears to be uncontested.*

09. It is important to highlight that it is the applicant's responsibility to report the change and present truthful facts before this authority under oath; if he fails to do so or provides false evidence, he will be prosecuted under *Section 193 of the Indian Penal Code, 1860*. He will face up to *seven years in imprisonment and a fine*. As a result, the applicant's evidence affidavit must have been considered in order to assess if a change occurred in the trust. Furthermore, no one objected until today. As a result, the change report seems to be undisputed. As a result, points 1 and 2 are answered in the affirmative. As a consequence, the change report deserved to be accepted. Hence, in order to answer point No.3 following order is passed:

ORDER

1. The change report is accepted
2. Schedule-I be amended accordingly
3. Application is disposed of accordingly.
