- Instalment 1 fees to be paid on or before 10<sup>th</sup> April 2026. Late fee will be applicable w. e. f 11<sup>th</sup> April 2026. Please refer to the table above for due dates and details.
- Late fee of Rs 10/ per day will be applicable for maximum 60 days from the fee payment due date and post that student would be automatically de-registered from the system. Once de-registered student will have to take fresh admission based on seat availability and all rules for new admission will be applicable.
- Classes for the new academic session would be allowed only on payment of instalment 1 fee as per the above-mentioned fee structure table.
- For new academic session all fee would be payable quarterly only and as per the timeline mentioned in the above table. All the payments must be of the exact amount as specified for that Installment. Part payments will not be accepted.
- A special discount of 5% on the school fees is applicable if the full year fee is paid on or before **31<sup>st</sup> March 2026**. To avail this discount parents are requested to visit the school office.
- For the Academic Year 2026-27, there will be no waiver whatsoever of any type given to students on fees except the relevant concessions according to the school's policies.
- The fee counter timings are from 9.00 am to 12.30 pm, Monday to Saturday (except fourth Saturdays and holidays).
