Assessment Framework and Promotion Policy

The school follows a comprehensive assessment approach for Classes VI to VIII.

Attendance Requirements:

Each student is required to maintain a **minimum attendance of 75%** during the academic session. Failure to meet this requirement will result in **disqualification from appearing in the Final Examination.**

Students are expected to avoid absence from examinations except in cases of **extreme emergency**, such as a **contagious illness or serious injury (e.g., fracture)**. In such cases, a **medical certificate or prescription issued by a registered medical practitioner**, along with relevant supporting medical reports, must be submitted to the school **within three working days of the absence.**

Passing Criteria for Classes VI – VIII:

Assessment of Classes VI and VII will be done on the same examination pattern as of Class VIII.

Passing Criteria for Class VIII

A student will be declared “**Pass**” and promoted to the next higher class at the end of the academic session only if he/she fulfills the following criteria:

- Secures a **minimum of 33% marks in each subject** studied during the session.
- Secures **an overall minimum of 33% marks, i.e., 33 marks out of 100.**
- In addition, promotion to the next higher class is subject to obtaining **at least 25% marks in each subject in the Annual Examination, i.e., 20 marks out of 80.**

Re-Examination:

A candidate appearing in the **Annual Examination** who fails in one or more subjects may be declared eligible to appear for the **Re-Examination** in the failed subject(s).

The Re-Examination will be conducted within **one month from the date of declaration of the Annual Examination results** and will follow the **same syllabus and examination pattern** as the Annual Examination.

The marks obtained in the **Internal Assessment (out of 20)** will be carried forward and added to the marks secured in the Re-Examination.

To be declared “**Pass**” in the Re-Examination, the student must secure:

- **At least 25% marks in each subject in the Re-Examination, i.e., 20 marks out of 80, and**

- **A minimum total of 33 marks out of 100** in the subject, including the combined weightage of **Re-Examination marks (80)** and **Internal Assessment marks (20)**.

Criteria for Essential Repeat:

If a student **does not secure at least 25% marks in the subject(s) in the Re-Examination**, i.e., **20 marks out of 80**, and **fails to obtain a minimum total of 33 marks out of 100** in the concerned subject(s), including Internal Assessment marks, or **does not appear for the Re-Examination**, he/she will be placed in the category of **“Essential Repeat” (ER)**.

A student of **Class VIII** who is not eligible for **Pass and Promotion** and is placed in the **“Essential Repeat” (ER)** category will be required to **repeat the same class in the following academic session**.

Missed Test / Exams:

Re-examinations may be conducted in cases of **medical emergencies, participation in official competitions (on duty), or the demise of an immediate family member**.

Students who are unable to appear for the **Annual Examination** due to the above-mentioned reasons, as well as those placed in **Compartment cases**, will be eligible to appear for the Re-Examination.

In any other exceptional circumstances, the decision regarding eligibility for Re-Examination shall rest solely with the **Head of the School**.

Use of Unfair Means:

Strict disciplinary action will be taken against students found **using unfair means** during examinations. The answer script of such students will be **cancelled**, and a **fresh answer script** will be issued for continuation of the examination. **Only the fresh answer script will be evaluated**.

Repeated use of unfair means will attract **severe disciplinary action and major penalties** as per the school rules.
